Dear Potential Grantee,

Preparation of the Town's fiscal year 2024 budget is underway, and applications for the Civic Support program are now being accepted.

The purpose of the program is to fund projects or programs of non-profit civic organizations, which primarily benefit residents of the Town of Middletown. To be eligible, organizations or projects must primarily serve the residents of the Town of Middletown, Aquidneck Island, or Newport County.

Each request for funding must be submitted on the Middletown Civic Appropriation Request for Funding form, and shall be accompanied by proof of agency's 501c(3) tax-exempt status and agency's budget from the prior three (3) years. Organizations that do not have a 501c(3) status must provide documentation that identifies the status they operate under.

Applications must be signed by an authorized officer of the organization and received by the Finance Office no later than March 1, 2023. Requests for funding will not be considered by the Town Council unless a complete application has been submitted in accordance with the program's requirements.

The following activities will not be funded with civic appropriations:

1. Programs or services that serve primarily non-Middletown residents
2. Political activities
3. Marketing and/or fundraising

All recipients of civic appropriations, prior to receiving funds, shall enter into an agreement with the Town regarding the use of said funds. The agreement shall require that a project status report(s) be provided to the Town Council at specified intervals.

CIVIC APPROPRIATION - APPLICATION REQUIREMENTS

PURPOSE To fund projects or programs of non-profit civic organizations, which primarily benefit residents of the Town of Middletown.

ELIGIBLE ORGANIZATION Only 501c(3) tax-exempt organizations are eligible for funding. To be eligible, organizations or projects must primarily serve the residents of the Town of Middletown, Aquidneck Island, or Newport County. Organizations that do not have a 501c(3) status must provide documentation that identifies the status they operate under.

APPLICATION Each request for funding must be submitted on the Town of Middletown's Civic Appropriation Request for Funding form, and shall be accompanied by proof of agency's 501c(3) tax-exempt status and agency's budget from the prior three (3) years. Organizations that do not have a 501c(3) status must provide documentation that identifies the status they operate under.

Applications must be signed by an authorized officer of the organization and received by the Finance Director no later than March 1, 2023. Applications can be emailed to mtanguay@middletownri.com.

Requests for funding will not be considered unless a complete application has been submitted in accordance with these requirements.

INELIGIBLE ACTIVITIES The following activities will not be funded with civic appropriations:

1. Programs or services that serve primarily non-Middletown residents
2. Political activities
3. Marketing and/or fundraising

AGREEMENT & REPORTING All recipients of civic appropriations, prior to receiving funds, shall enter into an agreement with the Town regarding the use of said funds. The agreement shall require that a project status report(s) be provided to the Town Council at specified intervals.
